Karl Aghassi has performed extremely well on two restoration projects on historic properties of mine. The initial project was for an 1861 brick bowfront townhouse in Boston's South End at 34 Montgomery Street. Karl was a very new contractor that we felt could succeed with this task. The building is in the National Historic District and any exterior work was required to conform to Landmark Commission requirements. The wooden soffit below the slate mansard roof had deteriorated to the point of inviting pigeons to roost. This was mostly due to the missing brackets and dentils, probably the result of a fire many years earlier. Karl – working 30 feet above the sidewalk on ladders – replaced the soffit, added newly made brackets (there was one remaining that we could replicate) and dentils and painted the entire area. 30 years later, all of his work was still very much intact.

The second project was my house at 165 Winthrop Rd in Brookline. A medieval revival home, built in 1891 by the famous architect Ralph Adams Cram, it is one of very few residences that he designed before turning his attention to churches and universities. The shingle style house had been clad with aluminum siding and we finally felt able to remove the siding, and replace the front porch and deck that was added years earlier, with a more fitting design - thus restoring the house to its original glory. We hired Karl for this project. Karl worked closely with my architect and a structural engineer, as after removing the siding, termite damage was discovered, causing a significant support for a cantilevered rear addition to be in danger of failure. Shoring was required. Karl managed to cope with all of the ins and outs of the uncovered issues and completed a high quality project. In the end, the house became a showpiece in the neighborhood and won the Preservation Award from the Town. Karl, along with myself, my wife, and my architect attended the ceremony. A few years later, the architectural historian and biographer for Ralph Adams Cram, Douglas Shand-Tucci visited, and was enamored with the restoration and the new front porch, which he thought was designed by Cram. He included the house in his book.

For these two projects, Karl proved to be a sensitive, realistic contractor with the ability to solve the inevitable unanticipated problems that often appear when working on historic renovations. His attention to detail and the quality of his work is highly commendable.
